**Cost:** (8 lessons) \$100

**Rain Outs:** Fridays during the session will be used for make-ups for inclement weather. We will make every attempt to get classes in;

Classes will be "called" no later than 20 minutes before the scheduled class start.

**Seahorses** (Ages 6 months – 36 months: infants and toddlers.)

Classes are for both parent and child. Lessons will focus on water adjustment, kicking motion and strength, floating, breath

holding and submersion, blowing bubbles and an introduction to water survival skills.

**Starfish** (approx. ages 2 ½ - 6) max. 1:4 teacher/student ratio *Red Cross Equivalent Level 1*

Beginning swimmers who need assistance in the water. Lessons will focus on rhythmic breathing, front and back floating, introduction to front and back swimming, and water safety. No ability requirement.

**Goldfish** (approx. ages 2 ½ - 6) max. 1:5 teacher/student ratio or less *Red Cross Equivalent Level 2*

Beginning swimmers who need assistance in the water but can float, tread water or has some independent water mobility; children will be assigned to this group based on ability.

**Goldfish (2)** (approx. ages 2 ½ - 6) max. 1:5 teacher/student ratio or less *Red Cross Equivalent Level 2*

For the experienced Goldfish!

**Private & Semi-Private Lessons – ALL LEVELS** (including Adult training and stroke technique)

Scheduling based on pool operation hours and instructor schedules. Cost: Private lessons \$25 per ½ hour, Semi-Private (2 children) \$40 per ½ hour, Semi-Private (3 children) \$55.5 per ½ hour. **Custom Groups Lessons – ALL LEVELS**
